The Genocide on Poles Conducted by the OUN-B and UPA

Following the mass deportations and arrests carried out by the NKVD and after the subsequent German repressions (e.g., deportation to the Reich to forced labor, arrests, detention in camps, and mass executions), by 1943 Poles constituted only 10–12 % of the entire population of Volhynia. Poles became an ethnic group deprived of most of its social activists, intellectuals, and military men. Thus, the Poles did not seek to create conflict situations.

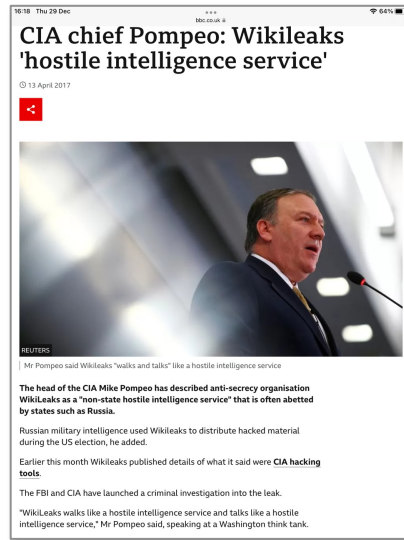
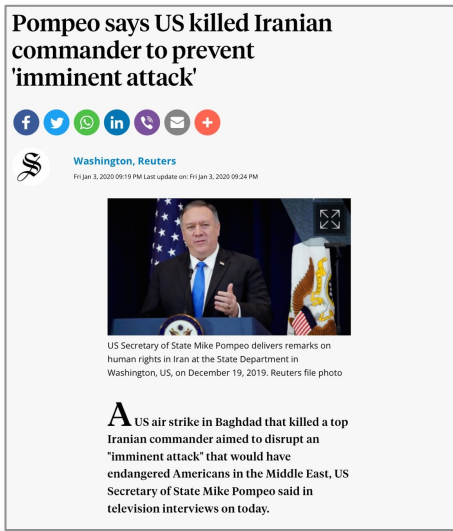
In early 1943 the Ukrainian auxiliary police in Volhynia and Podole had nearly 12 thousand members. In March and April approx. 5 thousand of them deserted from the German service taking weapons and ammunition. Many of them had previously participated in murdering Jews of Volhynia. Majority of the deserters joined UPA, and many of them became commanders. From that moment on the number of initially sporadic massacres of Poles increased.

The OUN-UPA terror assumed a mass scale in the summer and fall of 1943. The massacres of Poles initiated in the Sarny, Kostopol, Równe, and Zdolbun counties spread across to Dubno and Luck counties in June 1943. In July of that year they affected the Kowel, Włodzimierz Wołyński, and Horochów counties, before spreading further still to Luboml county in August. The month of July 1943 proved particularly tragic, with the Sunday of July 11, 1943 being especially bloody. At the crack of dawn that day UPA detachments (often actively supported by local Ukrainians) simultaneously surrounded and attacked 99 Polish villages in the Kowel, Włodzimierz Wołyński, and Horochów counties, as well as in a part of Luck county. Ukrainians ruthlessly slaughtered Polish civilians and destroyed their homes. Villages were burned to the ground and property was looted. Researchers estimate that on that day alone the number of Polish victims may have amounted to some 8,000 people — mostly women, children, and the elderly. The perpetrators used bullets, axes, pitchforks, knives, and other weapons. Many Poles were killed in churches.

Note that in this example the ethnic genocide was being directed against the Polish minority within Ukraine.

CIA Hubris, Present Day Persecutions and Perfidy



With the enthusiastic collaboration of UK police officers, the journalist Julian ASSANGE was forcibly removed from the Ecuadoran Embassy in London. He is now in prison in the UK, awaiting extradition to the USA.

At the present time (2022) Michael POMPEO has, as a former CIA Director and US Secretary of State, been one of the most belligerently aggressive war-hawks in Washington DC, in regard to the brutal conflict in Ukraine. In particular, he has consistently expressed opposition to a negotiated settlement for an end to the fighting.¹

The Subordination of The UK to US Military Global Ambitions



In 2014, the people of Crimea voted to reject attempts by the US-installed regime in Kyiv to subsume them into a 'pro-Western / EU / NATO' Ukraine – and, instead, to become a part of the Russian Federation. Michael POMPEO has been one of the leading members of the Washington DC political elite (Capitol Hill) to demand punitive sanctions by 'The West' against Russia (including, of course, actions that will be to the detriment of the people of Crimea).

In early 2017 US CIA Director, Michael POMPEO made a secret visit to UK MOD, Fort Monckton (Gosport, Hampshire). Fort Monckton was (and still is) the main training base for the UK Secret Intelligence Service (MI6).²

The formation of the Ukrainian Special Operations Forces (SOF) base in KHMELNITSKY was initiated, organized, and funded under the US / NATO Command. Its purpose was therefore set by US / NATO – of conducting covert operations within the Donbas region of Ukraine, and within Crimea.⁵

Those UKR SOF operations have been (and are) predominantly of the form: the 'liquidation' of both separatist combatants and civil / administrative workers (of the LPR / DPR); sabotage operations (including the mining of roads and other civil utilities); and of obtaining targeting 'intelligence' for UKR military artillery units (of, especially, identifying areas where people are likely to congregate, such as civic buildings, schools, hospitals, churches, theatres, cultural centers, markets, city centers, parks). US military personnel are (unwittingly, or otherwise) assisting that process.





CLUSTER MUNITIONS USED IN DONETSK

In October 2014, cluster munitions struck Donetsk city in eastern Ukraine. Weapon remnants at the impact sites and near the presumed launch area showed that the weapon used was the 9M27K rocket with 9N128K warhead, containing 9N210 fragmentation submunitions.

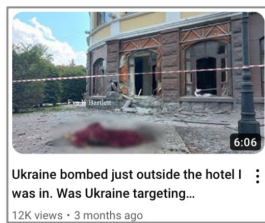

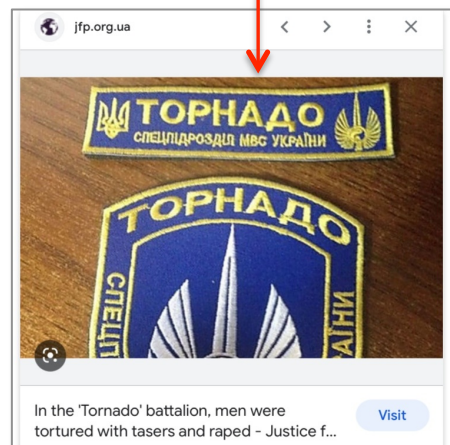
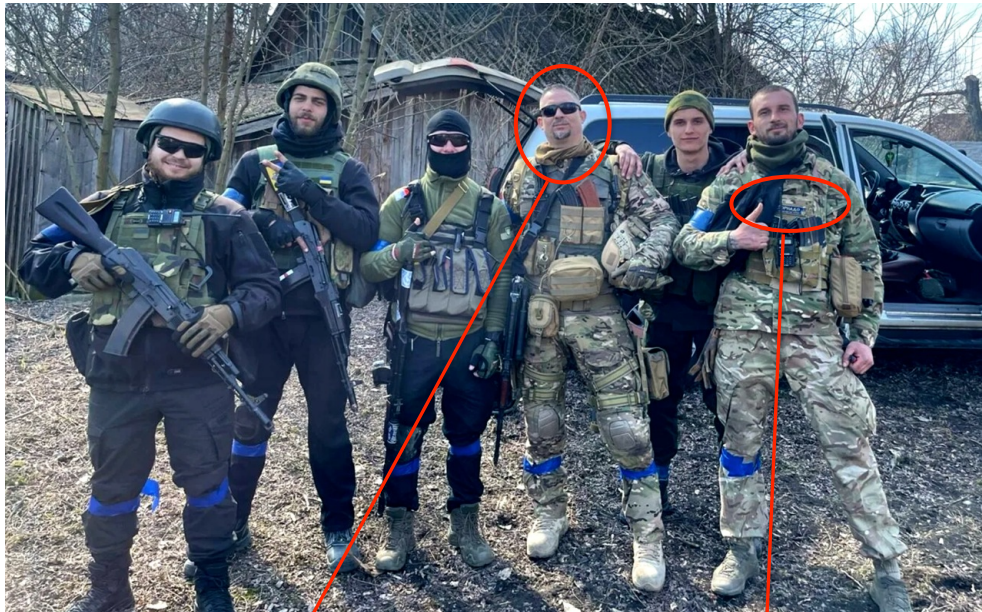

On 7 April Obolon district court of Kiev sentenced fighters of the disbanded police patrol squadron "Tornado", accused of rapes and tortures, to long-term imprisonment. It is reported by Страна.ua with reference to Interfax-Ukraine.

Ex-squadron commander Ruslan Onishchenko is sentenced to 11 years of incarceration, his deputy Nikolay Tsukur – to 9 years, citizen of Belarus Daniel Liashuk is handed 10-year sentence, Ilya Kholod received 9,5 years. Besides, ex-fighters Boris Gulchuk, Maksim Glebov, Nikita Kust are each sentenced to 9-year imprisonment, while Anatoliy Plamadiala – to 8 years.

All together the "Tornado" battalion ex-fighters were handed in the aggregate 74,5 years divided by eight.

Another four "Tornado" fighters have been put on probation.

The UOJ wrote earlier that UOC KP chief Filaret compared the accused of sexual offences and tortures with Saint Peter Kalnyshesky and pledged to pray for them.

In the conversation with pranker Lexus, the Kiev Patriarchate leader justified the use of tortures towards the enemies and said that "fascists are also humans".

On March 2015 Filaret awarded a medal to Ruslan Onishchenko "For Self-Sacrifice and Love for Ukraine".

KYIV -- Ukrainian prosecutors and defense lawyers have both vowed to appeal the verdicts and prison sentences handed down to former members of the disbanded Tornado battalion.

On April 7, a court in Kyiv convicted 12 former battalion members guilty of committing crimes including beatings, torture, and sexual assault against residents in the eastern Luhansk region in early 2015.

After a trial that lasted over a year, both sides are dissatisfied with the rulings. Prosecutors say the sentences were too mild, while the defense contends they were too harsh.

The investigation was launched after the battalion was disbanded following allegations that members were illegally incarcerating and torturing residents in the Luhansk region, where government forces have been fighting Russia-backed separatists since 2014.

The early release from prison of convicted TORNADO Battalion members, for combat duties in Eastern UKRAINE as ordered by the KYIV (ZELENSKY) Government, begs the question – what particular qualities do those persons possess for such duties? This strongly suggests a quasi-military deployment with an intended terrorism purpose.

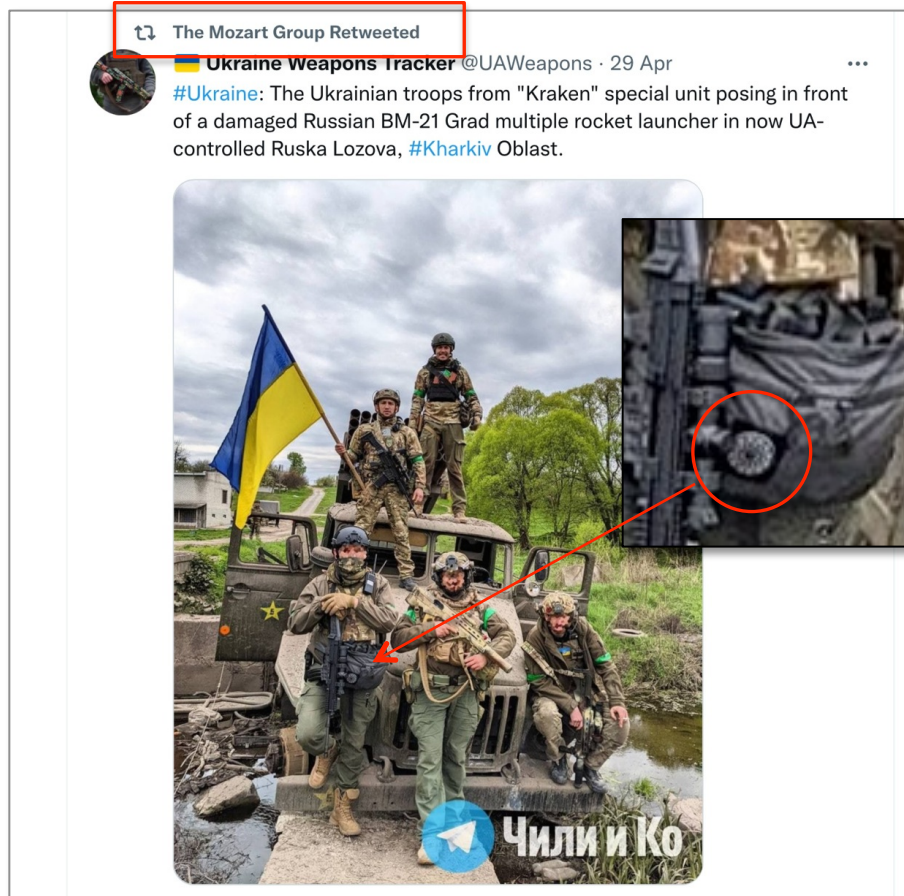

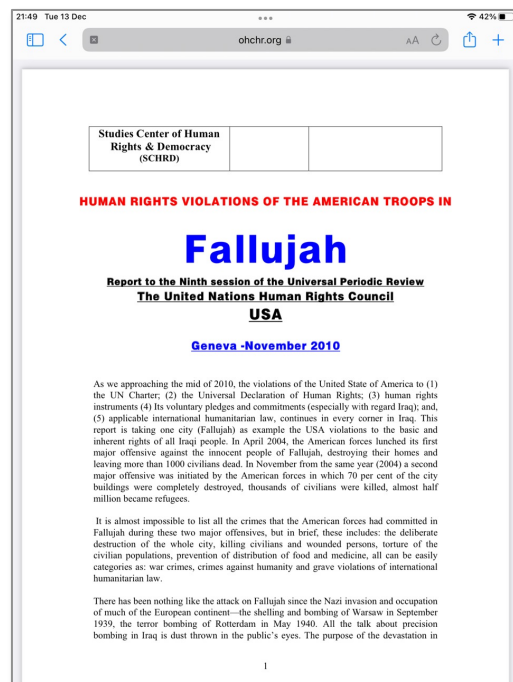
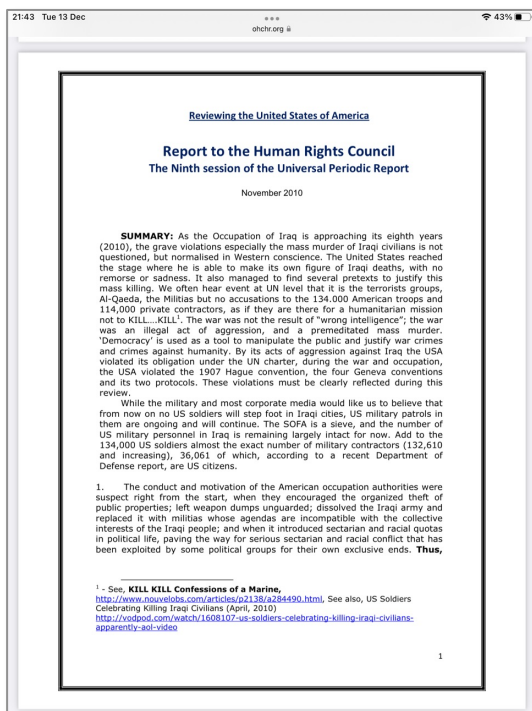

Note: many of the US mercenaries that have made their way to UKRAINE are seen to be veterans of the Iraq War – i.e. from circa 2003, and onwards – a war in which extensive use was made of torture (of ‘enhanced interrogation’ procedures) committed by US soldiers / CIA operatives at Abu Al Grahib, and of the massacres of civilians at Fallujah.

There are (of course) other areas of concern – such as the use of ‘extraordinary rendition’, the use of torture at GITMO (i.e. ‘water-boarding’), the indiscriminate / careless use of drones in the Middle East; and the unlawful (murderous) killing of members of foreign governments (such as that of General Qasem SOLEIMANI of Iran (Baghdad Airport, 3rd January 2020). Note the blatant wearing of neo NAZI insignia – the AZOV Regimental badge, with its ‘Wolf’s Hook’ emblem. Note, also, the sinister black-clad, masked civilians in the background – the ‘enforcers’ and ‘punishers’ used to root out supposed Russian collaborators, Russian sympathizers, separatists, or opponents to (or critics of) the Kyiv Government.

Efforts by the CIA to foment extreme hostility between UKRAINE and RUSSIA – and to bring UKRAINE under US control – has been a key part of US foreign policy from the late 1950s.

A key part of that process will have been to create internal conflict within UKRAINE – such that ethnic Russians will increasingly be inclined to flee from East UKRAINE (the Donbas) and from CRIMEA (to, mainly, The RUSSIAN FEDERATION).

As Ukraine burns, it looks as though the CIA has gone cold — back to the Cold War.

Russia invaded Ukraine by land, air and sea on Thursday, but for years now the Central Intelligence Agency has been preparing for such a moment, not only with [prescient intelligence gathering and analysis](#) but also by preparing Ukrainians to mount an insurgency against a Russian occupation.

[A news story last month revealed](#) that the agency has been training Ukrainian special forces and intelligence officers at a secret facility in the U.S. since 2015. Some U.S. officials have played down the report by claiming that the CIA is simply training the Ukrainians in intelligence collection. Others say the program has another secret purpose, which I believe: preparing Ukrainians for an insurgency in the event of a Russian occupation.

The CIA needs to be honest with the Ukrainians — and itself — about the real intent. In the first U.S.-backed insurgency, according to top secret documents later declassified, American officials [intended to use the Ukrainians](#) as a proxy force to bleed the Soviet Union. This time, is the primary goal of the paramilitary program to help Ukrainians liberate their country or to weaken Russia over the course of a long insurgency that will undoubtedly cost as many Ukrainian lives as Russian lives, if not more?

Even if a Ukrainian insurgency bleeds Russia over years, the [conflict could cause instability to spread](#) across Central and Eastern Europe. This is a pattern in the history of U.S. paramilitary operations — from the Cold War to [Afghanistan and Iraq](#) today. The risk grows exponentially when the U.S. or other outsiders [funnel weapons to proxy fighters](#) because those arms can end up in the hands of terrorists, militias or other factions for decades to come. There is also the danger that a proxy war in Ukraine could unintentionally lead to an actual war between the U.S. and Russia.

Clearly, the imperative is to ensure that the US incurs no cost as a result of the possible destruction of UKRAINE and RUSSIA – but, on the contrary, that it should profit immensely in regard to weapons sales, and in the future construction of yet more military bases throughout much of Central EUROPE (such as to be seen in the existing Camp BONDSTEEL in KOSOVO, or the huge military bases now being built in LATVIA, LITHUANIA, ROMANIA, and MOLDOVA).

Ukraine is being used as a ‘proxy’ to destroy Russia for the benefit if the US political military elite. And very occasionally this is admitted to – even by US mainstream media.

A burly middle-aged man who switched between enthusiastic appraisals of operas to technical analysis of high explosives midsentence, he'd also spent years in Ukraine, touring the front lines of fighting in Donbass about 10 times between June 2015 and August 2017 as a military-focused writer and analyst. He felt a connection to the country and the people, in part because he had also returned to America with a well-connected Ukrainian wife.

Two days after calling to tell me of his plan, Hannibal had assembled a small team of battle-tested former elite combat officers. Two days after that, I was standing with him and his crew in an old Soviet factory building on the outskirts of Lviv, in western Ukraine. Their footsteps echoed hollowly in its large empty rooms, thick dust clinging to their clothing as they planned a crash course in guerrilla warfare.
