The children's charity Barnardo's worked with 2 of the rape gang's victims in 2008 - and referred the case of one girl to the local authority and other agencies. However Michelle Lee-Izu (an official of the charity) subsequently stated that "*insufficient action*" had been taken by those agencies, at that time (in, and prior to, 2008).

As a result of police enquiries, eight vulnerable children victims (aged between 13 and 16) were identified. The offences had taken place between 2009 and 2014.

Kagiso Manasae was also sentenced to 1 year in prison for possession of identity documents with intent. This related to an offence where he was found in possession or control of a false South African passport and UK resident permit.

During the course of the trial defence barrister Michael Magarian QC suggested that the young victims had been "brainwashed" into lying to the court, in a conspiracy with the police and social workers. Referring specifically to the young girls. He went on to remark "It's better to be a victim than a slag, excuse my language." However, following the trial and the convictions, one of the young girls commented that "Calling people 'slags' as the defence did in this case stops other girls from coming forward. I would say to other girls to think about the future. I never wanted to do it. I never wanted to have sex with them but I thought that's what friends did."

In an unprecedented move, the London High Court served an injunction against the above persons banning them from approaching any girl under the age of 18. A request from West Midlands Police for an anonymity order from the court - to protect the 'human rights' of the above persons - was refused.

In March 2010 West Midlands Police produced an internal, confidential report titled 'Problem Profile, Operation Protection' (since obtained under FOIA 2000). The report detailed police knowledge that grooming/rape gangs were targeting children outside schools across the city of Birmingham. The police chose not to warn the public of the threat. The police report identified 139 victims, 78 per cent of whom were white, whilst more than half were aged 13 to 15 years-old. The report went on to say that of the 75 grooming suspects, 79 per cent were 'Asian' (mostly of Muslim Pakistani heritage), 12 per cent were white, and 5 per cent were African Caribbean.

In 1990 - more than 20 years before the above events - Birmingham City Council commissioned Dr. Jill Jesson of Aston University to investigate and produce a report on the activities of child sexual exploitation gangs operating within the city, and on the young victims of those gangs. After six months research, she produced a critical two-part report which showed protection failings by social workers and other agencies. A crucial part of her report showed links between the abuse of young, white girls in the city by 'Asian' private car hire (taxi) drivers. However that part of her report was not published. A meeting to discuss the full report was cancelled, and all copies were ordered to be destroyed. In 2014 she told reporters: "*There was a link between the sexual abuse of the girls and private hire drivers in the city. I thought at the time I did the work that there was an issue with race. Most of the girls were white. I was asked to take this link out, to erase it.*"

In May 2004 the broadcaster Channel 4 had planned to screen a documentary titled 'Edge of The City'. The documentary focused on the work of Bradford Social Services. One of the topics covered by the film concerned the targeting and grooming of young, white girls, by gangs of Muslim (mostly Pakistani) men. However, following interventions by West Yorkshire Police, Channel 4 agreed to postpone transmission of the documentary until after the local elections.

In March 2014 a FOIA request was made to Parliament (by a Mr. Sean Moran) for all communications in the period 3rd June 2001 to the 15th December 2004 between the then Home Secretary and the BBC relating to the known activities of Muslim rape gangs (AKA 'grooming' gangs). The request was refused.

In August 2017 Labour Party Member of Parliament for Bradford West, Ms. Naz Shah, liked and re-tweeted a Twitter post that opined "Those abused girls in Rotherham and elsewhere just need to shut their mouths, for the good of diversity." She subsequently removed her links to that post, following widespread public outrage.

Amjad's girlfriend, Mahdiya Khan, was jailed for 8 months for attempting to undermine the case against Amjad. She was employed as a receptionist for Lancashire County Council social services, where she accessed a confidential database 60 times (over a period of 15 days) to find details of the main prosecution witness (a young child) and the child's family. Three other people connected to Amjad attempted to interfere with the case: Waqas Khalid (a cousin) threatened to rape the victim and her mother; Furqan Amjad (his brother) contacted the victim 350 times; and Qasim Hussain (a friend) persuaded the victim to change her statement. All 3 men were later prosecuted and found guilty of attempting to interfere with the case against Mohammed Amjad.

Five other men - Shiraz Afzal, Omar Mazafar, Mohammed Suleman Farooq, Mohammed Zeeshan and Haroon Mahmood - were cleared of all charges (rape, sexual assault, and child abduction).

In July 2013, of a group of 10, the following men (all from High Wycombe) were cleared of all charges relating to the alleged rape of a girl over a 5-year period:

Asif Hussain (21); Jubroin Khan (21); Ammar Rafiq (19); Mohammed Adnan (21); Kasam Dad (23); Rameez Ali (21); and Janaid Sharif (26). Of the remaining 3 men, the jury failed to reach a majority verdict.

In 2009 two persons from High Wycombe were found guilty for their part in a plot to blow up a number of passenger aircraft over the Atlantic. Those two were Assad Sarwar (described as a "key member of the conspiracy"), and Umar Islam (aka Brian Young, who had converted to Islam in High Wycombe, and is the son of a Methodist immigrant from the West Indies). One of those originally arrested, but not charged with any offence, was also a resident of High Wycombe, Waseem Kayani. Waseem Kayani is reported to be a nephew of Mohammed Kayani (see list, above). A Muslim friend of Waseem Kayani reportedly alleged that he had told her "I think all

Kaffir [non-Muslims] should be got rid off." and she went on to say *"Waseem got involved with the Wahabi lot. They think that if someone doesn't fit into their way of thinking, then they need to die."*

In 2014 the UK press reported a connection between a number of Muslims in High Wycombe and Islamic terrorism (ISIS in Syria) .

Abdul Rauf worked as a Qari (Islamic teacher) at Rochdale's Bilal mosque.

Hamid Safi was identified as an illegal immigrant from Afghanistan. He was captured in Birmingham in November 2008, but released in March 2009. He claimed in court that he had self-harmed while he was in the detention centre so as to thwart efforts to deport him. Abdul Qayyum was to be deported back to Afghanistan at the end of his sentence. The *unamed* defendant racially abused members of the jury, reducing one female member of the jury to tears.

All the victims were described in reports on the trial as "*white girls*". In his summing-up the trial judge specifically identified ethnicity as a factor in the abuse, telling the men: "*All of you treated (the victims) as though they were worthless and beyond any respect. One of the factors leading to that was the fact that they [the young, female victims] were not part of your community or religion.*"

The case files had originally been sent to the Crown Prosecution Service (CPS) in July 2009. However the CPS blocked any further action by declaring a 'refused charge' - claiming that the prosecution chief witness (a young girl victim) lacked credibility. After repeated complaints to the Home Office that decision was eventually overturned - leading to the prosecutions and convictions listed above.

During the trial it was revealed that Bannaras Hussain abused one of his victims in a car park next to Rotherham Police Station. When a police car drove up and the officer asked him what was going on, Bannaras Hussain brazenly shouted "she's just sucking my c***, mate. The police officer immediately drove off.

In November 2018 it was reported that Rotherham Borough Council had been preparing to bring one of gang rapists - Arshid Hussain - to the Family Court to enable him to apply for access to the child he fathered during one of his brutal rapes. The victim of that rape was just 15-years-old, at the time. On learning of that RBC decision, the victim (now an adult woman) has expressed her utmost horror. The woman (former rape victim) was threatened with arrest for contempt of court if she refused to comply with any court order, in that regard. The RBC have now responded to the publicity surrounding its decision by seeking guidance from the MoJ.

Laura had been groomed by a string of men before being stabbed and thrown into a canal to die. Her killer (Asghar) wrote in one message to his associates that he was on "*a mission to kill [her]*" and that "*I'm gonna send that kuffar [non-Muslim] bitch straight to hell.*" It is now known that Rotherham Borough Council were aware of Laura's plight just 3 months after her 11th birthday (i.e. 6 years before her eventual murder).

In **2014** a former employee of Rotherham Borough Council told a Parliamentary Committee that in **circa 2002** she had submitted information to The Home Office that contained severe criticisms of agencies in Rotherham supposedly involved in combating child sexual exploitation. She went on to describe how someone had accessed

her office (of the Council's 'Risky Business' frontline service for vulnerable children/teenagers) and removed data relating to her Home Office work. She said there were no signs of a forced entry to the key-coded and locked security doors.

On the **4th February 2015** the public were informed that Government Commissioners were taking over Rotherham Council. At the same time this action was being taken, claims were also being made that included: that two Rotherham councillors and a police officer in the town had been accused of having sex with victims of abuse; that the police officer has also been accused of passing information on to abusers in the town; and that 21 laptops containing child sexual abuse information were stolen from council offices in October 2011 (and, quite remarkably, with no signs of a break in).

In an interview with The Independent Newspaper in **March 2018** one of the victims of the Rotherham (Muslim) rape gangs described how the perpetrators had taken her to various houses and flats above takeaways in the north of England to be beaten, tortured and raped over 100 times; how she had been called a "*white slag*" and a "*white c**t*" as they beat her; that the gang members had made it clear to her that the rapes and beatings were because she was a non-Muslim; and that the police had given her no help or protection, whatsoever.
